In continuation of this Ministry's Sanction letters of even number dated 15.12.2015, 17.08.2016 and 06.06.2017 thereby sanctioning an amount of Rs.9490.96 lakh and releasing Rs.6785.26 lakh for the project "Integrated Development of New Eco Tourism under Swadesh Darshan - North East Circuit at Thenzawl & South Zote, District Serchhip and Reiek, Mizoram' under Swadesh Darshan Scheme", I am directed to convey the financial sanction of the President of India for release of **Rs. 807.31 lakh towards balance of the 3rd installment** for this project. The total amount released for the project including the present release comes to Rs.7592.57 lakh against the sanction amount of Rs.9490.96 lakh.



The above expenditure is debitable to Demand No.95-Tourism; 3452-Tourism (Major Head), 01-Tourist Infrastructure (Sub-Major Head), 01-101-Tourist Centres (Minor Head), 14-Swadesh Darshan - Integrated Development of Theme-Based Tourist Circuit, 14.00.31 Grants in Aid General for the year 2017-18 (Revenue).

2. The Mizoram Tourism Development Corporation has furnished utilization certificate Rs.5067.30 lakh against the funds released by the Ministry. The unspent balance of 1st and 2nd installment is now nil.
