

Sir,

This is in continuation to Ministry's sanction letters of even number dated 15.12.2015 and 17.08.2016 thereby sanctioning an amount of Rs.9490.96 lakh and releasing Rs.4745.28 lakh (Rs.1898.00 lakh as 1st installment and Rs.2847.28 lakh as 2nd installment) to Mizoram Tourism Development Authority for the project - Integrated Development of New Eco Tourism under Swadesh Darshan- North East Circuit at Thenzawl & South Zote, District Serchhip and Reiek in Mizoram. I am directed to convey the sanction of the President of India for the release of **Rs.2039.98 lakh as 1st part of 3rd installment** for this project. The total amount released for this project including the present installment would be Rs. 6785.26 lakh against the sanctioned amount of Rs. 9490.96 lakh.

The expenditure involved is debitable to Demand No.95-Tourism; 3452-Tourism (Major Head), 01-Tourist Infrastructure (Sub-Major Head), 01-101-Tourist Centres (Minor Head), 14-Swadesh Darshan - Integrated Development of Theme-Based Tourist Circuit, 14.00.31 Grants in Aid General for the year 2017-18 (Revenue).
