| 7. Accounts Assistant | - 1 post in pay level 7. |
| 8. MIS Coordinator | - 1 post in pay level 7. |
| 9. Project Assistant | - 1 post in pay level 6. |
| 10. IV Grade | - 2 posts at prevailing MR/PE wages or minimum wages as prescribed by Government of Mizoram from time to time. |

As per approval, the Mizoram Tourism Development Authority shall be eligible to receive financial aid in the form of Grants-in-Aid from the State Government, Central Government or any other sources to meet the salary cost of its employees engaged against the above-mentioned posts under the said authority.

All functionaries of the Mizoram Tourism Development Authority including members of the Board of Governors, their Powers and Functions, Memorandum of Association and Rules and Regulations of the Mizoram Tourism Development Authority, etc. shall be as notified by the Government from time to time.
