Through this NIT, Pre-Qualification cum Tender is invited for **DEVELOPMENT OF PILGRIMAGE & HERITAGE TOURISM INFRASTRUCTURE UNDER PRASHAD SCHEME OF MINISTRY OF TOURISM, GOVT. OF INDIA IN MIZORAM** on QCBS system as per Scope of work defined in this tender, from Contractors / Agencies / Companies/ Firms /Individual/ Sole Proprietor/Limited/Private Limited in two Part system i.e.

**(a) Part No. I: i) Technical Bid- (online submit also submit hard copy)**

**ii) Presentation (Not Online submitted and the same is Hard Copy only submitted).**

**Note: Presentations should be a maximum of 12-15 pages/slide only.**

**(b) Part No. II: Financial bid- only Online.**

**The procedure for participation in e-tendering**

**The bids/proposals shall be submitted in 2 (two) parts:**

**Part I shall be named "Technical Bid" and shall comprise;**

***Envelope-1:*** Containing Cost of Tender Document and an Amount of Earnest Money Deposit / Bid Security Declaration as per Enclosure-1 as prescribed in NIT or Exemption certificate in Tender document fee & EMD for Micro, Small & Medium Enterprises. The envelope should be superscribed as **"Envelope 1 – Tender Cost/EMD/ Bid Security Declaration form/ Exemption certificate** for Development Works at Heritage Khuangchera Cave, Reiek and PFC at Reiek Peak."

***Envelope-2:*** Containing all documents required as prescribed in Technical Bid, other parts of Tender and Presentation.

The envelope should be super scribed as **"Envelope 2 – Development Works at Heritage Khuangchera Cave, Reiek and PFC at Reiek Peak"** In the technical proposal, there should not be any indication about the prices (printed or otherwise) of any of the products offered.

All the documents comprising Part I will have to be submitted online through e-portal <https://mizoramtenders.gov.in> except Presentation. And all the document comprising Part I submitted in **HARD BOUND** (Hard bound implies such binding between two covers through stitching or otherwise whereby it may not be possible to replace any paper without disturbing the document) form with all pages sequentially numbered either at the top or at the bottom right-hand corner of each page e.g., by writing page 1 of 10 on page 1, if total pages are 10. It should also have an index giving page wise information of above documents.

All the sealed envelopes should again be placed in a sealed cover super scribed as "Development Works at Heritage Khuangchera Cave, Reiek and PFC at Reiek Peak."
