Dear Sir,

This mail is with reference to the project "Integrated Development of New Eco Tourism under Swadesh Darshan- North East Circuit at Thenzawl & South Zote, District Serchhip and Reiek, Mizoram" sanctioned under Swadesh Darshan scheme of Ministry of Tourism in the State of Mizoram.

Ministry was in the process of release of 5th instalment. However, with reference to attached letter following compliances are required from State for release of funds:

1. There was a total interest of Rs. 0.78 Cr. out of which the State has utilized Rs. 0.51 Cr. on Civil Components and requested to adjust the same in next installment. This is in violation of GFR 230(9) and GoE OM dt. 9th march 2022 Para 3(Viii) which states that the interest earned from the funds release is to be mandatorily remitted to CFI and cannot be adjusted against future releases. The same needs to be remitted through the Bharat Kosh Portal.

 2. GFR 239 states that UC should be countersigned by the Administrative Secretary of the Division regulating the Scheme/Finance Secretary. In this instance, the UC has not been countersigned by either of the designed authorities of the State Government.
3. The release shall be processed post compliance of the above observations.
