In continuation of this Ministry's sanction of even number dated 27.03.2017 thereby sanctioning an amount of **Rs. 9907.00 lakh** and releasing an amount of **Rs.1981.00 lakh** for the project 'Development of Eco-Adventure Circuit Aizawl- Rawpuichhip-Khawhphawp- Lengpui- Durtlang- Chatlang- Sakawrhmutuaitlang- Muthee-Beratlawng- Tuirial Airfield- Hmuifang under Eco circuit theme of Swadesh Darshan Scheme', I am directed to convey the sanction of the President of India for the release of Rs.2482.16 lakh (Rs. 2972.10 lakh minus Rs. 489.94 lakh) towards payment of first part of 2nd installment. 

The Payment of Rs.2482.16 lakh (**Rupees Twenty Four Crore Eighty Two Lakh and Sixteen Thousand only**) will be arranged by Drawing and Disbursing Officer of the Ministry of Tourism by presenting a bill to Pay and Accounts Officer, Ministry of Tourism for electronic transfer of funds in favour of Mizoram Tourism Development Authority-Account No: 390010100021386 of Axis Bank, Aizawl Branch, House No. A/69/A, Chanmari, Aizawl, Mizoram having IFSC code UTIB0000390 .

The expenditure may be made under Demand No.95-Tourism; 3452-Tourism (Major Head), 01 Tourist Infrastructure (Sub-Major Head) 01.101 Tourist Centres (Minor Head)14- Swadesh Darshan-Integrated Development of Theme-Based Tourist Circuits 14.00.31 Grant-in-Aid-General for the year 2017-18 (Revenue).

4. The State Govt. of Mizoram has furnished utilization certificate for an amount of Rs.1491.06 lakh (more than 75%) against Rs.1981.00 lakh released by the Ministry as first installment.


