OFFICE MEMORANDUM

Subject : Matters relating to Isolated Post.

Attention of all Administrative Departments and Heads of Department is hereby invited to this Department's Office Memorandum No. A.11012/3/2010-P&AR(ARW) dt.2.8.2012 that while scrutinizing the information on the said matter submitted to this Department, it is learnt that certain authorities did not pay due attention to the issue by including some posts identified as non-isolated and excluding the isolated post within the realms of isolated posts, thereby making it difficult to arrive at correct data of the employees falling under such category.

Further, it should be noted that the term 'Isolated Post' simply means those posts having no promotional avenue and feeder post, i.e. the post which stands alone. However, it is learnt that there are some posts which were isolated at the time of original creation but have feeder post subsequently as a result of amendment or introduction of new Recruitment Rules or re-structuring of the hierarchy of the post in the Department. In such cases, it should be noted that if such post is not provided with further promotional avenue, they shall remain Isolated Post and the introduction of new feeder post will not affect its status. Some of the relevant posts in such cases are – Duftry directly recruited by some Departments and also Non-Matriculate Group 'D' employees whose promotional avenues like Process Server, Duftry, CA-II had already been declared as withering post by the Government Vide. No. B.12013/2/2003-P&AR(ARW) dt.12.8.2003. Further, it may also be noted that there are certain posts which were isolated at the time of original creation but later given promotional avenues by way of amendment or introduction/framing of new Recruitment Rules, etc. In such cases, the posts originally identified as Isolated will no longer be included in the list of Isolated Posts.

All concerned authorities are, once again, instructed to have a fresh look into the matter and take remedial measures on the issue promptly and cautiously so as to ensure that no mistake recurs. Action should be taken on or before 31.10.2012 before submission of the information to DP&AR(ARW).
