**OFFICE MEMORANDUM**

Tourism Department has vehicles under Directorate of Tourism and Mizoram Tourism Development Authority (MTDA) which are allotted to officers for performing official duties. Monthly quota of the POL/fuel is also provided for all vehicles. Earlier, vehicles purchased by Mizoram Tourism Development Authority (MTDA) were issued monthly quota of POL by the MTDA, however, with the change in the procedures for release of funds and refund of interest accrued on project funds under Central Sector Scheme to the Consolidated Fund of India, vehicles under Tourism Department should be treated as one entity under Tourism Department only

Due to refund of interest accrued to the Consolidated Fund of India by the MTDA from the Financial Year 2022-2023, MTDA is not in a position to clear outstanding liabilities on vehicle repairs and provide monthly quota of POL to officers in the Directorate of Tourism and MTDA who have been purchasing POL from their own expenses for quite some time. It has been decided by the Government that all repairs of vehicles with POL under Tourism Department shall be under the direct supervision of Director, Tourism Department with immediate effect and until further orders.

Therefore, in the interest of public service, it is hereby informed to all concerned that all expenditure on repairs of vehicles and purchase of POL under Tourism Department (Directorate of Tourism and Mizoram Tourism Development Authority) shall be arranged by Directorate of Tourism. Mizoram Tourism Development Authority shall also assist Directorate of Tourism in clearing bills and purchase of POL wherever possible.

Finance & Accounts Officer who has been looking after finance and accounts matters of Directorate of Tourism from other Department shall continue to receive monthly quota of POL which shall be decided by Director, Tourism Department. Officers who purchased POL for the last 3 (three) – 4 (four) months from their own expenses are also informed to submit bills/vouchers to Directorate of Tourism for re-imburement.
