OFFICE MEMORANDUM

Aizawl, the 27th January, 2021.

With a view to streamline the amount of fees charged by consultancy firms/individual consultants for preparation of Detailed Project Report (DPR) and for monitoring and supervision in civil works, the State Government of Mizoram hereby fix the rates of consultancy charges as indicated below –

1. For preparation of Detailed Project Report (DPR) in civil works :
 - (1) For a project costing below ₹ 100 lakh, the maximum ceiling for consultancy charges will be 2% of the cost of the construction.
 - (2) For a project costing ₹ 100 lakh to ₹ 500 lakh, the maximum ceiling for consultancy charges will be 1.5% of the cost of the construction.
 - (3) For a project costing above ₹ 500 lakh, the maximum ceiling for consultancy charges will be 1% of the cost of the construction.
2. For preparation of Request for Proposal (RFP) and bid evaluation, 0.4% of the construction cost may be charged in respect of Sl.No. 1(1), 0.3% in respect of Sl.No. 1(2) and 0.2% in respect of Sl.No. 1(3).
3. For monitoring and supervision in civil works, the consultancy charges will be 3% of the construction cost irrespective of the cost of construction.

The contents of this Office Memorandum shall be effective immediately and it may be brought to the notice of all concerned by every Administrative Department and Head of Department in their respective Departments.
